

bit.bio New Lab Discount – Terms & Conditions

By applying for this program, you agree to the following terms and conditions (“**New Lab Terms**”):

1. **The following definitions apply in these Data Exchange Terms:**

“**bit.bio**” means Bit Bio Limited registered in England and Wales with company number 10466798.

“**bit.bio Standard Terms**” means bit.bio’s Standard Terms and Conditions for the Supply of Goods and Services available on bit.bio’s website (www.bit.bio)

“**you**” or “**your**” means the person or firm who applies to participate in this program.

2. **Terms and conditions**

2.1 **Eligibility and Application**

(a) You must meet all the following criterias:

- be a principal investigator or lab manager;
- in position to establish a new lab at an academic institution, in position to establish relocate a lab to a new lab premises (lab relocation); or a recipient of a young investigator award; and
- affiliated with an academic institution.

(b) You must submit a complete application to bit.bio within six (6) months of starting the new lab or given the award.

(c) You agree to provide relevant documentation to confirm your eligibility, which must include at least the following:

- proof of the lab establishment, relocation or award; and
- details of your affiliation with the academic institution.

(d) bit.bio reserves the right to request additional information as needed to verify your eligibility.

(e) bit.bio reserves the right to approve or decline your application for this program at its sole discretion.

(f) bit.bio may cancel this program at any time without prior notice. If bit.bio cancels the program after you have submitted your application, unless bit.bio contacts you to inform that you have been successfully selected, your application will not proceed.

2.2 **Voucher Terms**

(a) If your application is successful, you will receive a 50% discount voucher for the purchase of up to a maximum of 100 units of small ioCells.

(b) The voucher is valid for 12 months from the date of issuance and any unused voucher will expire automatically.

(c) The discount voucher is valid for the purchase of ioCells and not valid for purchase of any other bit.bio goods or services.
