1. The following definitions apply in these Data Exchange Terms:

"bit.bio" means Bit Bio Limited registered in England and Wales with company number 10466798.

"bit.bio Standard Terms" means bit.bio's Standard Terms and Conditions for the Supply of Goods and Services available on bit.bio's website (www.bit.bio)

"you" or "your" means the person or firm who applies to participate in this program.

2. Terms and conditions

2.1 **Application**

bit.bio reserves the right to approve or decline your application for this program at its sole discretion.

2.2 Product Use

You may purchase up to a maximum of **three small vials** or **one large vial** per product for their proof-of-concept experiment subject to bit.bio's Standard Terms.

2.3 **Submission Requirements**

- (a) You agree to use the purchased bit.bio product(s) to perform proof-of-concept experiments and provide to bit.bio:
 - a summary of your experimental outcomes;
 - submissions that must include images and supporting data; and
 - an explanation of how bit.bio's product performed including any unexpected results, hereinafter together the "**Results**".

2.4 Data Sharing & Usage

- (a) By participating in this program, you agree that all information disclosed to bit.bio including but not limited to the Results may be used by bit.bio, its affiliates and its contractors for marketing and advertising of bit.bio's products and profile.
- (b) You confirm that you have the right to share the Results with bit.bio and where relevant, you have obtained consent from any co-authors to accept this Data Exchange Terms.
- (c) You confirm that you are authorised to enter into this Data Exchange Terms and where relevant, you have obtained consent from your employer to accept this Data Exchange Terms.
- (d) If the Results are confidential, it is your responsibility to let bit.bio know of such restrictions. bit.bio may consider delaying publication for an appropriate timeline but no longer than 12 months from the date of receipt for when the data can be publicly shared.
- (e) You agree to remove any personal data from the Results before sending to bit.bio.

2.5 Voucher Terms
